INVITING EXPRESSION OF INTEREST (EOI) FOR ONBOARDING OF UTKARSH BANGLA EMPANELLED TRAINING PROVIDERS (TPs) FOR CONDUCTING SKILL DEVELOPMENT TRAININGS UNDER LOI MODULE FOR PURULIA DISTRICT.

District Project Management Unit (DPMU). PBSSD, District Purulia invites Expressions of Interest from the eligible empanelled Utkarsh Bangla Training Providers (TPs) for expanding the skill ecosystem under the Utkarsh Bangla program of the State Government for delivery of quality skill development training of various domains and their alignment with District Skill Development Plan (DSDP).

1. Eligibility Criteria:

- (i) TP must be previously enrolled under Utkarsh Bangla Program.
- (ii) TP is neither Blacklisted nor Dis-empanelled any time before from any of the schemes.
- (iii) No adverse reports/complaints are pending against the TP and awaiting disposal.
- (iv) TPs are eligible to apply if their registered office or at least one of their TC is/was situated within the Purulia District.
- (v) Maximum of 15 (fifteen) enrolled TPs are allowed for on boarding under LOI module subject to approval of the DPMU.
- 2. Procedure for the necessary proposal by the TP and further action by the DPMU:
- (i). Expression of Interest may be submitted from the Utkarsh Bangla empanelled TPs in the wake of the notice floated in the e-portal of the Purulia District Administration (https://purulia.gov.in/).
- (ii) The Expression of Interest (EOI) with relevant documents must reach to the District Magistrate, Purulia District, Utkarsh Bangla Section (PBSSD), 3rd Floor, New Collectorate Building, P.O.- Purulia, Dist.-Purulia, Pin- 723101through e-mail (E-mail ID-utkarshabanglapurulia@gmail.com) within two weeks from the date of issue of the notice.
- (iii) Application to be submitted by the TP (on the official letter-pad of the TP) furnishing the following details in the format attached with the notice:
 - a. Name of TP and TP Code under PBSSD.
 - b. Full Address of the registered office of the TP.
 - c. Proposed domains.
 - d. Past performance of the TP under Utkarsh Bangla.
 - e. Contact details of TP along with email.
- (iv) The Expression of Interest (EOI) will be considered if it is submitted by the TPs within the specified time limit as above.
- (v) At the time of Shortlisting/Final selection of the TP the past performance of the TP under Utkarsh Bangla will be considered by the DPMU.
- (vi) The decision of the DPMU shall be final.


