# EXPRESSION OF INTEREST (EOI) FOR EMPANELMENT OF TRAINING PARTNERS/ TRAINING CENTRES FOR CHILDCARE QUALIFICATIONS WITH HEALTHCARE SECTOR SKILL COUNCIL (HSSC), NEW DELHI

The Healthcare Sector Skill Council (HSSC) is inviting Expression of Interest (EOI) from eligible and experienced training partners/ training centres for empanelment to implement pilot training programs for training of women in three new national qualifications approved for childcare economy in a time-bound project. In addition, women master trainers also need to be trained. This initiative aims to enhance the employability of women workforce in the Early Child Development (ECD) Services through high-quality training programs.

Apart from above, women master trainers and trainers to be trained and certified in all the 3 mentioned roles.

### **Preferred Locations are as follows:**

Delhi NCR (New Delhi), Bihar (Patna), Tamil Nadu (Coimbatore & Tirupur), Karnataka (Hubbali-Dharwad, Bengaluru), and Maharashtra (Pune, Aurangabad). But other locations could also be considered.

### **Expected Deliverables and timeline:**

- Affiliation Process to be completed by 30<sup>th</sup> November 2025
- Trainee Mobilization and ToT certification of master trainers and trainers to be completed by 10<sup>th</sup> December 2025.
- Training, certification and placement of women trainees in the 3 mentioned qualifications to be completed by 10<sup>th</sup> March 2026 followed by complete report in HSSC desired format by 31<sup>st</sup> March 2026.
