Eoi for submission of Project Proposals under DDU-GKY 2.0 in Haryana

Haryana State Rural Livelihoods Mission (HSRLM) invites proposals under Deen Dayal Upadhyaya Grameen Kaushalya Yojana 2.0 (DDU-GKY 2.0) from Project Implementing Agencies (PIAs) having fresh Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD), GoI for placement linked skill development training under DDU-GKY 2.0 for a total of 1270 candidates in the state of Haryana. Interested PIAs under category-B, C & D may submit their proposal online at <https://Kaushal.rural.gov.in> and are advised to go through the detailed guidelines and SoP of DDU-GKY 2.0 (available on <https://Kaushal.rural.gov.in>) before applying online.

While preparing the proposal, latest CNN (Cost Norm Notification) is to be taken into account. Further, PIAs may keep into consideration below mentioned points before applying:

- Training for target of 1270 candidates will be for residential courses only. As per availability, the target may increase/decrease.
- Duration of the course to be undertaken as such so that the training of the sanctioned target is completed by 31st December 2027 and appointment for placement by 31st March 2028.
- Applicant agency should submit proposal with duration of the courses with minimum 576 hours of skilling and maximum 2304 hours of skilling.
- 5% beneficiaries of total target must be from Persons with Disability (PwDs).
- The preference will be given to the applicants who applied for training to target groups such as manual scavengers, transgenders, Persons with Disability (PwDs), victims of trafficking, rehabilitated bonded labour and other vulnerable groups besides offering higher wages than minimum applicable wages for the State of Haryana, including more than 70% placement and mobilization from Aspiration District i.e. Nuh.

The PIA will have to pay non-refundable application fees for an amount of Rs. 25,000/- (Rupees Twenty Five Thousand only) plus applicable GST. Further, the PIA will have to deposit non-refundable fee of Rs. 1,25,000 (Rupees One Lakh Twenty Five Thousand only) towards Qualitative Appraisal plus applicable GST, if the initial screening is successful and recommended for Qualitative Appraisal. The PIA will make the payment through NEFT/ RTGS to the bank account of NIRDPR, Hyderabad as given below:
