Tenders from established firms are invited to the institute which is capable for providing infrastructure, raw material, and machinery etc. (as per QP and requirement) for conducting outreach skill development training programs such as ORP etc.

The details of which are given below: -

- 1. Tenders are invited from the reputed Infrastructure Partners.
- 2. The bidder should submit sufficient document proof that they have prior experience as a service aggregator.
- 3. Tenders should be submitted along with a tender fee of Rs 1000/- (non-refundable) and Rs 20,000/- (refundable/as per rule) EMD through DD in favor of "**Director**, **CFTI**, **Agra**. Separately
- 4. The bidder with experience in conducting or coordinating various skill development training programs like ORP, UPSDM, ODOP, VSSY, etc., will be preferred.
- 5. **ORP (Outreach program)**—the bidder should quote (in **Annexure 5**) the basic rate as per training programmes as mentioned at **Annexure-2** to provide the aggregator services. which includes infrastructure & services as mentioned in **Annexure-1**
- 6. The bidder should submit the bids separately for each qualification pack as mentioned in **Annexure-1** (job role for ORP), which includes Sample Maker-Footwear, Cutter-Footwear, Stitching Operator-Footwear, Pre-Assembly Operator-Footwear, Lasting Operator-Footwear, Shoe Maker, Skiving Operator-Footwear, etc.
- 7. The training of 60 trainees—SC/ST and General/OBC inclusive—with a training capacity of 30 trainees with 4 hrs per day/at a time (30-30 candidates in 2 batches). Minimum 10% candidates belongs to Gen/OBC categories are mandatory in every batch.
- 8. Payment will only be released to the training partner by the institute only for those candidates who have successfully passed in assessment carried out by the assessment agency
- 9. SC/ST candidates (only online verified caste certificates will be considered) are exempted from the course fee as per the rules. The candidates belongs to Gen/OBC categories will be charged the fees @ Rs 49/- per hour per candidates, which will be paid by the candidates before commencement of the training programme _through DD or NEFT in favour of "Director, CFTI Agra".
- 10. The bidder should quote competitive prices applicable to educational institutes like CFTI, Agra, being a premier training institute in the country.
- 11. The sealed quotation super scribing the date for advertisement of the tender, the name of the Qualification Pack, and the due date should be addressed to the **Director**, **Central Footwear Training Institute**, C-41/42, Industrial Area, Sikandra, Agra-282007
- 12. Last date of submission of tender will be **24.12.2025**, & late tender is liable to be rejected, and the tender opening date will be communicated separately.
- 13. Quotations should be submitted in separate sealed bids (technical bids in a separate sealed envelope and financial bids in a separate sealed envelope) containing documents of proof of being a reputed infra partner and commercial bids, respectively.

- 14. The number of districts trainees may be increased or decreased as per the requirement / administrative reasons.
- 15. The quotation should clearly indicate the minimum time required for arranging the required infrastructure; the lead time should be strictly adhered to.
- 16. Opened tenders or tenders through email will not be entertained.
- 17. Quotation shall be valid for a minimum period of one year from the last date of the submission of bids. (This may increase or decrease depending on the performance.)
- 18. The Institute reserves the right to alter, cancel, accept, modify, or vary the requirements, any terms, & conditions, and specifications, etc., or reject or postpone the project either fully or partly without assigning any reason thereof.
- 19. Where counter terms and conditions of business have been offered. CFTI, Agra, shall not be deemed to be governed by these and bound by them unless specific written acceptance thereof has been given by CFTI, Agra.
- 20. The quotations should clearly indicate in the technical/ finical bids the percentage of tax and other charges levied, if any.
- 21. For all the matters concerned and not covered herein above, the decision of the Director, CFTI, Agra, shall be final and binding on the parties.
- 22. All the disputes arising out of the contract shall be subject to Agra jurisdiction (UP) India only.
- 23. The training charges will be proportionately increased or decreased as per the duration and facilities provided by the infra partner.
- 24. The annual turnover of the bidder should be a minimum of 50 lakhs and above in the last two years, 2023-24 and 2024-25.
- 25. The bidder will ensure in writing that all training documents and information (during and after the training program) not be disclosed to any other outside persons.
- 26. The bidders should submit the GST registration certificate/other supporting proofs along with the tender documents.
- 27. The bidder should submit sufficient documentation substantiating that they have relevant experience in providing infrastructural support for skill development training programs under any state/central government schemes or similar work experiences along with the customer list as per **Annexure-4** (Customer List) and the annual audited account for the last 3 years.
