**EXPRESSION OF INTEREST (EOI) FOR ONBOARDING OF UTKASH BANGLA EMPANELLED TRAINING PROVIDERS (TPs) FOR CONDUCTING LIVELIHOOD SKILLS DEVELOPMENT TRAINING TO MEMBERS OF LAMPS IN COLLABORATION WITH TRIBAL DEVELOPMENT DEPARTMENT UNDER UTKARSH BANGLA.**

District Project Management Unit (DPMU), PBSSD, District Bankura invites Expressions of Interest from the eligible Utkash Bangla Training Providers (TPs) for livelihood skills development training to members of LAMPS in collaboration with Tribal Development Department under Utkarsh Bangla under SANKALP scheme.

**Eligibility Criteria:**

1. Only rated. Graded TPs/ nationally recognized TPs as per PBSSD norms will be eligible to provide training.
2. Must have been neither blacklisted nor Dis-empanelled at any time before from any of the Department's schemes.
3. No adverse/complaints are pending against the TP and awaiting disposal.
4. Should be willing to provide training in the locations indicated by WBTDCC which is close to the residence of LAMPS members.

**Procedure for the necessary proposal by the TP and further action by the DPMU:**

1. Interest may be submitted from the UB empanelled TPs in the wake of the notice floated in the e-portal of the Bankura District Administration (<https://bankura.gov.in/>).
2. The notice period for the necessary proposal would be, from date of publication of interest (20/12/2024) till one week (27/12/2024).
3. Applications on official letter-head of TP to be submitted from the concerned TP furnishing the following details:
  - a) Name of TP and TP Code under PBSSD.
  - b) Full Address of TP.
  - c) Contact details of TP along with email.
  - d) Experience in tailoring.
  - e) ToT certified Trainer details in tailoring sector.
4. Short listing/final selection of the TPs shall be done by the DPMU/ Committee on receipt of EOI's from the interested TPs within the period allowed.
5. The decision of the DPMU/Committee shall be final.
