## **1. Overview of ASDM**

Assam Skill Development Mission (ASDM) is registered under Society Registration Act, 1860 in 2015 and is working under the aegis of Skill, Employment & Entrepreneurship Department (SEED), and Government. The Mission started functioning from January, 2017 as an apex body of all skill activities to achieve skilling and gainful employment for the youth of the state. ASDM also aims at creating a sustainable skill ecosystem for convergence of quality skills training and also encourage budding entrepreneurs in different sectors. ASDM is implementing the state-funded Placement linked Skill Development Training Programme and Centrally-funded Pradhan Mantri Kaushal Vikas Yojana for providing short term training on various skills which are in high demand. Further, ASDM has established state of the art North East Skill Centre in collaboration with ITEES, Singapore which provides one-year certificate courses in the sectors of Beauty & Wellness, Hospitality, Housekeeping, Food and Beverage Service and Retail Services. Further, more, ASDM is also implementing the establishment of the first of its kind in the entire region the Assam Skill University with financial assistance from Asian Development Bank (ADB).

## **2. Assam Building and Other Construction Workers Welfare Board(ABOCWWB) under Commissionerate of Labour, Govt. of Assam**

The Commissionerate of Labour, Assam formulates projects, policies, and schemes for worker's development, enacts State Acts and Rules when necessary, and provides social security benefits to unorganized workers, including those in the construction sector.

The Commissionerate dynamically incorporates legal provisions, ensuring occupational safety, health, and hygiene in workplaces. By performing statutory and quasi-judicial functions, the Commissionerate addresses industrial disputes arising from various labour problems. The Commissionerate is committed to promote a labour market conducive to investment, positive industrial relations, eradication of child and bonded labour and overall economic growth. Through appropriate legislations, inspection, compliance monitoring, and social dialogue, it strives to maintain the welfare of the labour force and achieve a sustainable economy.

3. **Scope of Work:**

1. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation will be empaneled for imparting skill training.
2. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall provide pre placement offer letters (LOI) along with the tender documents. The LOIs shall be from organizations with valid labour licenses and having GST registration. The phone numbers and mail ID given in the LOI should be active, ASDM would counter check the validity of those LOI. If no response from companies on LOI issue is not received within 07(Seven) working days, the LOI so issued will be treated invalid.
3. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall employ qualified and experienced Personnel / trainers having the minimum qualification and experience parameters as specified by the industry or respective Sector Skill Councils for their respective curriculum. The trainers should be having industry experience and should be associated with the industry for imparting training or should be Sector Skill Council certified (SSC) Trainers.
4. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation will be responsible for candidate mobilization / counseling of candidates and carrying out training, assessment, certification and post certification tracking of the successfully certified candidates. All candidates should have valid Adhaar card **with proof of registration under BOCW. Dependents of registered construction workers should provide the proof of relationship with the registered workers. Stipend to be provided to registered BOCW construction workers only. Dependents as candidates will not be provided stipends.** Biometric device as per ASDM MIS compatible devices to be installed along with IP enabled CCTV camera and high speed broad band internet for conduct of skill training.
5. Also, ASDM shall monitor program performance as per the envisaged monitoring & evaluation framework. The entire task of Program Monitoring and Evaluation shall be conducted through various means including an online Management Information System (MIS) that has been designed, developed and deployed by ASDM.
6. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation acting as the Training Center for conducting classes should be as per SSC norms and should contain all the equipment and training facilities vis a vis the job roles for conducting Skill Training programme.
7. The target will be allocated based on job roles mentioned in Tech-7

8. Target Allocation to qualified “NCVT/SCVT affiliated ITI s having NSDC SMART accreditation “training centers is the sole decision of Mission Director, Assam Skill Development Mission(ASDM)
9. The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall facilitate assessment of candidates on completion of training curriculum and placement of certified candidates. The digital transcript of the assessment to be shared with both ASDM and the candidate. Post placement tracking of the candidates is to be done by NCVT/SCVT affiliated ITI s having NSDC SMART accreditation
10. The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation (applicant) should submit employment strategy with the tender document.
11. The residential training duration per day shall be 6-8 hours per day for Short Term Training.
12. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation needs to provide the equipment’s for the training at the premises.
13. The maximum batch size will be 30 beneficiaries; the minimum batch size will be 20.
14. The training duration of a project shall be as per the Qualification Pack (QP) of the Job role.
15. A candidate should have at least 70% attendance to be eligible to appear for Assessments.
16. Biometric attendance duly verified by DPMT or ASDM officials or ABOCWWB officials is to be submitted during submission of invoices.
17. Assessment and certification shall be done by concern Sector Skill Council (SSC) appointed assessment agencies.
18. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation will be responsible for the on-ground planning, management and implementation of various activities leading to desired outcome under the project.
19. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation will closely work with all stakeholders associated with the project for overall coordination and achievement of the project objectives.
20. NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall organize awareness/orientation sessions on the training program by organizing workshops, seminars, and public campaigns including information dissemination on benefits of curriculum.

25. Candidates who are unable to pass the assessment, despite attending all classes, should be provided remedial classes/ extra classes/ additional assessment as required without any additional cost.

## **10 Right to accept any Bid and to reject any or all Bids:**

ASDM reserves the right to accept or reject any proposal, and to annul the tendering process and reject all proposals at any time prior to award of work, without thereby incurring any liability to the affected applicants or any obligation to inform the affected applicants(s) of the grounds for action so taken. Also, ASDM reserves the right to cancel or modify this NIT at any time.

## **11 Validity Period:**

- i. The proposals shall be valid for a period of 180 days from the date of submission of bids. A proposal valid for a shorter period may be rejected as non-responsive. On completion of the validity period, unless the applicant withdraws his proposal in writing, it will be deemed to be valid until such time that the applicant formally (in writing) withdraws his proposal.

- ii. In force majeure circumstances, at its discretion, ASDM may solicit the applicant/bidder's consent for an extension of the validity period. The request and the responses thereto shall be made in writing/email.
- iii. Performance Security of 5 % of Work order to be submitted along with a validity of 3 months after the work completion. MD, ASDM reserves the right to decide the establishment of non-performance by NCVT/SCVT affiliated ITI s having NSDC SMART accreditation

## **12 Force Majeure**

### **I. Definition:**

- For the purposes of this Agreement, “Force Majeure” means an event which is beyond the reasonable control of a Party, and which makes a Party’s performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.
- II. Force Majeure shall not include insufficiency of funds or failure to make any payment required here under.
- III. For the purposes of this Agreement, “Force Majeure” means an event which is beyond the reasonable control of a Party, and which makes a Party’s performance of its obligations here under impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, epidemic, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.
- IV. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or agents employees thereof, nor (ii) any event which a diligent Party could reasonably have been expected to both (A) take into account at the time of the conclusion of this Agreement and (B) avoid or overcome in the carrying out of its obligations here under.
- V. ASDM will decide the eventuality of Force Majeure which will be binding on both the parties.

## **13 No Breach of Agreement:**

The failure of a Party to fulfil any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement so far as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Agreement.

### **I. Measures to be taken:**

A Party affected by an event of Force Majeure shall take all reasonable measures to remove such party's inability to fulfill its obligations hereunder with a minimum of delay. A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible and in any event not later than fourteen (14) Days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give notice of the restoration of normal conditions as soon as possible. The Parties shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

- II. **Extension of Time:** Any period within which a Party shall, pursuant to the Agreement to this NIT, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.
- III. **Consultation:** Not later than thirty (30) days after the applicant has, as the result of an event of Force Majeure, become unable to perform a material portion of the Services, the Parties shall consult with each other with a view to agreeing on appropriate measures to be taken in the circumstances.

### **13.1 Notification procedure for Force Majeure**

- 1. The affected Party shall notify the other Party of a Force Majeure event within seven (7) Days of occurrence of such event. If the other Party disputes the claim for relief under Force Majeure it shall give the claiming Party written notice of such dispute within thirty (30) days of such notice.
- 2. Upon cessation of the situation which led the Party claiming Force Majeure, the claiming Party shall within seven (7) days hereof notify the other Party in writing of the cessation and the Parties shall as soon as practicable thereafter continue performance of all obligations.

### **13.2 Consultation and duty to mitigate**

The affected Party shall, at its own cost, take all steps reasonably required to remedy and mitigate the effects of the Force Majeure event and restore its ability to perform its obligations under this Agreement as soon as reasonably practicable. The Parties shall consult with each other to determine the reasonable measures to be implemented to minimize the losses of each Party resulting from the Force Majeure event. The affected Party shall keep the other Parties informed through written communication of its efforts to remedy the effect of the Force Majeure event and shall make reasonable efforts to mitigate such event on a continuous basis and shall provide written notice of the resumption of performance hereunder.

### **14. Dispute Resolution: -**

The parties will try to mutually resolve any disputes as far as practically possible. In case, the dispute could not be resolved mutually, the parties will go for Arbitration. The place of Arbitration will be at Guwahati only. Also, all legal matters arising out of this agreement will be subject to the jurisdiction of the Hon'ble courts situated at Guwahati only.

### **15. Additional Clause**

**16.** That the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall commence the work (skill training) not later than 30 days from the date of release of the targets to the Training centres in the MIS system of ASDM

**17. General Terms and Conditions: -**

**17.1 Definitions of terms:**

In this NIT (as hereinafter defined) the following words and expressions shall have meanings hereby assigned to them except where the context requires otherwise:

- I. “Applicable Law” means the laws and any other instruments having the force of law in India for the time being.
- II. “NCVT/SCVT affiliated ITI s having NSDC SMART accreditation means the training centers which provides skill training and is empaneled by Assam Skill Development Mission.
- III. “Contract Agreement” shall mean the agreement between the ASDM Authority and the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation duly signed by the parties to the agreement through their authorized representative, for the execution of the work as prescribed in the scope of work of this document and all terms and conditions mentioned here.
- IV. “Day” means calendar day.
- V. “ASDM” means Assam Skill Development Mission (ASDM) that has entered into the contract with the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation.
- VI. “Government” means the Government of India /Assam.
- VII. “Party” means “ASDM” being the First Party or the “NCVT/SCVT affiliated ITI s having NSDC SMART accreditation” being the Second Party, as the case may be, and “Parties” means both of them.
- VIII. Cost & Process Norms will mean the Cost & Process norms as are notified from time to time by ASDM.
- IX. “Services” means the work to be performed by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation pursuant to this NIT
- X. “Third Party” means any person or entity other than “ASDM” or the “NCVT/SCVT affiliated ITI s having NSDC SMART accreditation”.
- XI. “In writing” means communicated in written form with proof of receipt.
- XII. “Programme” means Skill Development Programme of the State of Assam.

**17.2 Authorized Representatives:**

Any action required or permitted to be taken and any document required or permitted to be executed under this NIT by ASDM or the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation may be taken or executed by the officials as specified hereunder:

- I. Mission Director of ASDM for the First Party.
- II. Authorized person of the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation (Power of Attorney to be submitted as per Annexure..... by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation).

**17.3 Relationship between the Parties:**

Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between ASDM and the NCVT/SCVT affiliated ITIs having NSDC SMART accreditation. The NCVT/SCVT affiliated ITIs having NSDC SMART accreditation, subject to the Agreement under this NIT, has complete charge of their Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

**17.4 Notices:**

- I. Any notice, request or consent required or permitted to be given or made pursuant to the contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by registered post to such Party at the address specified in the Contract.

**17.5** The 2<sup>nd</sup> Party may change its address or the training center address only with due approval of ASDM hereunder by giving the notice in writing of such change or in the case of ASDM, if notified vide a notification/ office order/ circular and displayed on the website.

**17.6 Location:**

The Services/skill training shall be performed in the State of Assam, at such locations as are approved in MIS system of ASDM.

**16.5 Taxes and Duties:**

- I. The NCVT/SCVT affiliated ITIs having NSDC SMART accreditation shall be responsible for meeting all tax liabilities arising out of the Contract or in the course of provision of its services.
- II. The income tax etc., if applicable, shall be deducted at source from the payment to the NCVT/SCVT affiliated ITIs having NSDC SMART accreditation as per the law in force at the time of payment.

**17.7 Fraud and Corruption**

It is ASDM's policy to require that ASDM as well as NCVT/SCVT affiliated ITIs having NSDC SMART accreditation should observe the highest standard of ethics during the execution of the contract. Neither ASDM nor the NCVT/SCVT affiliated ITIs having NSDC SMART accreditation shall engage in any corrupt, fraudulent, coercive or restrictive practices during the term of the Contract or any extension thereof.

In pursuance of this policy, for the purpose of this provision, the terms are set forth herein below: -

- I. "Corrupt practice" means the offering, receiving, or soliciting, directly or indirectly, of Anything of value to influence the action of a public official in the selection process or in contract execution;
- II. "Fraudulent practice" means a misrepresentation or omission of facts in order to influence a selection process or the execution of the contract;



**17.8** “Coercive practices” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process, or affect the execution of the contract;

VI. “Restrictive practice” means forming a cartel or arriving at any understanding or arrangement among organizations with the objective of restricting or manipulating a full and fair competition in the selection process or the execution of the contract.

## **17 Suspension:**

ASDM may, by written notice of suspension to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation , without any obligation (financial or otherwise) suspend all the payments to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation hereunder if the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall be in breach of the Agreement or shall fail to perform any of its obligations under the Agreement, including the carrying out of the Services; provided that such notice of suspension:

- I. Shall specify the nature of the breach or failure, and
- II. Shall provide an opportunity to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation to remedy such breach or failure within a period not exceeding thirty (30) days after receipt by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation of such notice of suspension. The above action will be taken by ASDM as and when deemed fit.

In case of non-fulfillment of the terms of this Agreement, ASDM reserves the right to suspend or terminate the agreement, forfeit the Performance Guarantee, recovery of the payments or installments released to the concerned NCVT/SCVT affiliated ITI s having NSDC SMART accreditation and may also Blacklist the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation in case of malpractices.

III. Inspection of TP’s training centers will be monitored, supervised and evaluated as per Standard Operating Procedures of ASDM.

## **18 Termination for Default:**

ASDM may, without prejudice to any other remedy for breach of Agreement, by a written notice of default of at least 30 days sent to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation, terminate the Agreement in whole or in part. The reasons for termination shall include but not limited to the following cases:

- I. If it is discovered at any stage that the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation has been furnishing false claims or providing misleading information with respect to enrolment of trainees, conduct of training or any other aspect related to the programme.
- II. If the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation in the judgment of ASDM, is found to be engaged in corrupt, fraudulent, coercive and restrictive or collusive practices in competing for or in executing the Agreement.
- III. If the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation commits breach of any condition of the Agreement.
- IV. If the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation is disempaneled at any stage during the course of the Agreement.
- V. The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation

fails to comply with any final decision reached as a result of arbitration proceedings;

- VI. The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation fails to comply to the decisions of the ASDM;
- VII. The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation submits to ASDM a statement which has a material effect on the rights, obligations or interests of ASDM and which the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation knows to be false;
- VIII. As the result of Force Majeure, the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation is unable to perform a material portion of the Services beyond the stipulated time, even after giving ample opportunities by ASDM. MD, ASDM reserves the right to decide on the time frame and number of opportunities to be given to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation.

**18.1 Termination for Insolvency-** ASDM may at any time terminate the Agreement by giving a notice of at least 30 days to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation if the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation becomes bankrupt or otherwise insolvent. In such event, termination will be without compensation to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to ASDM.

**18.2 Termination for Convenience –** ASDM, by a written notice of at least 30 days sent to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation may terminate the Agreement, in whole or in part, at any time for its convenience. The Notice of Termination shall specify that termination is for ASDM's convenience, the extent to which performance of the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation under the Agreement is terminated, and the date upon which such termination becomes effective.

**18.3 Cessation of Rights and Obligations and Services:** Upon termination of this Agreement or upon expiration of this Agreement, all rights and obligations of the Parties hereunder shall cease, except;

- I) Such rights and obligations as may have accrued on the date of termination or expiration,
- II) the obligation of confidentiality,
- III) The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation obligation to permit inspection, copying and auditing of its accounts and records by ASDM
- IV) Upon termination of this Agreement by notice of either Party to the other Party, the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every able effort to keep expenditures for this purpose to a minimum.

**19. Batch extension and invoice submission timelines, Recovery.**

Batch date extension will be allowed only one time subject to submission of valid justification for extension by NCVT/SCVT affiliated ITI s having NSDC SMART accreditation and acceptance of the same by MD, ASDM.

The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation should raise

1<sup>st</sup> installment bill within one month (30 days only) of batch start date, 2<sup>nd</sup> installment bill within one month (30 days only) of declaration of result of a particular batch and 3<sup>rd</sup> installment, within one month (30 days only) of the completion of the batch cycle, i.e. of completion period of three (3) months post placement of the candidates. Beyond the prescribed time limits, bills will be rejected. Also, recovery of amount disbursed to the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation will be initiated if it fails to claim 2<sup>nd</sup> installment within the time limit and/or for the failed candidates in the assessment process. Hostel invoices should be raised of the candidate of the concerned batch within 30 days of assessment or else the invoice generation will be blocked.

20. **Forfeiture of Performance Security(PS):** Performance Security will be forfeited for the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation not completing the full life Cycle of the training program as per defined timeline.

The PS submitted by the NCVT/SCVT affiliated ITI s having NSDC

SMART accreditation may be forfeited in the following cases:

1. If the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation s disempanelled for any reason.
2. If the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation does not start training of candidates within 30(Thirty) days of receiving the workorder.
3. If the contract is terminated for default or insolvency.
4. 4. Any other case, if the ASDM so decides.

## 21. airness and Good faith

**Good Faith:** The Parties undertake to act in good faith with respect to each other's rights under this Contract and to adopt all reasonable measures to ensure the realization of the objectives of this Contract.

**Operation of the Contract:** The Parties recognize that it is impractical in this NIT to provide for every contingency which may arise during the life of the Contract, and the Parties hereby agree that it is their intention that this Contract shall operate fairly as between them, and without detriment to the interest of either of them, and that, if during the term of this Contract either Party believes that this Contract is operating unfairly, the Parties will use their best efforts to agree on such action as may be necessary to remove the cause or causes of such unfairness.

As far as possible, any disputes between the parties shall be amicably solved with mutual understanding and written consent by both the parties.

## 22. Books and Records

NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall maintain a separate Bank Account for receiving payments from ASDM and incurring all expenditure relating to the scheme in the form of Cash Book, Cheque issue register,

vouchers for expenditure etc.

### **23. Mutual rights and obligations**

The mutual rights and obligations of ASDM and the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall be as set forth in the Contract, in particular:

The NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall carry out and complete the Services in accordance with the provisions of the Contract; and ASDM shall make payments to NCVT/SCVT affiliated ITI s having NSDC SMART accreditation in accordance with the provisions of the Contract, cost norms and process norms after making relevant deductions and conduct of due diligence and audit.

### **24. Safety regulations**

In respect of all the trainers and trainees engaged by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation directly or indirectly involved in the training programme and part of this Agreement, the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation shall at his own expenses arrange for all the safety provisions as per the applicable laws in force.

### **25. General rules**

Smoking, consumption of tobacco/alcohol or use of any abusive substances by any trainer and trainees and any personnel engaged by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation within the entire area of the training centre and in the institute campus in general are strictly prohibited. Violators of this rule shall be prosecuted as per law and discharged immediately from the training. Security and appropriate behavior towards trainees should be taken care of by the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation.

### **26. Interpretation**

If the context so requires, singular means plural and vice versa

Any waiver of a Party's rights, powers or remedies under the agreement must be in writing, dated and signed by an authorized representative of the party granting such waiver and must specify the right and the extent to which it is being waived.

Subject to the conditions of the above clause, no relaxation, forbearance, delay or indulgence by either party in enforcing any of the terms and conditions of the agreement or the granting of time by either parties to the other shall prejudice, affect or restrict the right of that party under the agreement, neither shall any waiver by either party of any breach of agreement operate as waiver of any subsequent or continuing breach of agreement.

Severability: If any provision or condition of the agreement is prohibited or rendered invalid or unenforceable, such prohibitions, invalidity or unenforceability shall not affect the validity or Enforceability of any other provisions and conditions of the agreement.

### **27. Governing law**

The Agreement shall be governed by and interpreted in accordance with

the laws of the Assam State/ The Country (India).

## **28. Jurisdiction**

The Parties to the agreement hereby submit to the jurisdiction of the Hon'ble Courts situated at Guwahati only for the purpose of actions and proceedings arising out of this contract.

## **29. Amicable settlement:**

In case of dispute between the parties regarding any matter under the contract, either Party of the contract may send a written Notice of Dispute to the other party. The Party receiving the Notice of Dispute will consider the Notice and respond to it in writing within 30 days after receipt. If that party fails to respond within 30 days, or the dispute cannot be amicably settled within 60 days following the response of that party, the Parties may go for Arbitration.

## **30. Arbitration:**

In the case of dispute arising upon or in relation to or in connection with the contract between ASDM/Authority and the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation, which has not been settled amicably, any party can refer the dispute for Arbitration under (Indian) Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be conducted by the sole arbitrator. The Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof, shall apply to these arbitration proceedings. The decision of the arbitrator shall be final and binding upon both parties and the parties agree to be bound thereby and act accordingly. The Arbitration proceedings shall be held in Guwahati, Assam only. The limitation period for referring the dispute to the Arbitrator will be 90 days from the first instance of dispute.

## **31. Payment Terms**

Training fees payments would be released as per updated cost and process norms document released by ASDM from time to time.

ASDM shall disburse the payment after all due verifications have been done for the submitted documents as required against each installment which has been defined in the cost and process norms as updated from time to time. Also, the NCVT/SCVT affiliated ITI s having NSDC SMART accreditation has to claim bill for each of its installments within time limits prescribed for the necessary process of training for that installment. No bill will be received beyond that period for the respective installment.

## **32. Location:**

The selected NCVT/SCVT affiliated ITI s having NSDC SMART accreditation should feed (Latitude & Longitude) the exact location in the MIS system as per the issued Work Order. In case, for any change of address, approval needs to be taken from ASDM authority.


