## **Eol for Submission of Project Proposals under DDU-GKY 2.0**

Haryana State Rural Livelihoods Mission (HSRLM) invites proposals under Deen Dayal Upadhyaya-Grameen Kaushalya Yojana (DDU-GKY) 2.0 from the Project Implementing Agencies (PIAs) having Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD) for placement linked skill development training under DDU-GKY for a total of **1846** candidates in the state of Haryana. Interested PIAs of different categories may submit their proposal online at <a href="www.kaushal.rural.gov.in">www.kaushal.rural.gov.in</a> and are advised to go through the detailed Guidelines & SOP of DDUGKY 2.0 (available on <a href="www.ddugky.gov.in">www.ddugky.gov.in</a>) before applying online. While preparing the proposal, latest CNN (Cost Norm Notification) is to be taken into account. Further, PIAs may keep into consideration below mentioned points before applying:

- (i) Training will be for Residential courses ONLY.
- (ii) Duration of the course to be undertaken as such so that sanctioned training target is completed by 31<sup>st</sup> December 2025 and appointment for placement by 31<sup>st</sup> March 2026.
- (iii) Preference will be given to the applicants who apply for captive employment providing higher wages than minimum applicable wage rate in Haryana, more than 70% placement target, PwD candidates and mobilization from Aspirational District i.e. Mewat.
- (iv) Proposals for the specific target groups such as manual scavengers, transgenders, Persons with Disabilities, victims of trafficking, rehabilitated bonded labor and other vulnerable groups will be preferred.

The PIA will have to pay non-refundable application fee for an amount of Rs 25000/- (Rupees Twenty-five thousand only) plus applicable GST. Further, the PIA will have to non-refundable Qualitative Appraisal fees of Rs 125000/- (Rupees One Lakh Twenty-five thousand only) plus applicable GST, if the initial screening is successful and recommended for Qualitative Appraisal. The PIA will make the payment through NEFT/RTGS to the bank A/C of HSRLM given below:
