1. Terms of Reference for Longitudinal Study on the impact of residential training of secondary school teachers.

<u>Background</u>: It has been witnessed that enrolment in Science stream in higher secondary level has decreased over the last few years. This has been an area of concern. In order to popularise the science subject from lower classes so that students find it interesting and will to opt for it in the higher classes, initiative of residential training for teachers of secondary level was undertaken in 2022-23. Training programme was for 5 days to cover 1 day in each of the subjects were Chemistry, Physics, Mathematics, Biology and General English including the exposure to Science Laboratory. The training programme was conducted in phased manner and coverage was as follows:

Now, in order to see the impact of the residential training, it is planned to conduct a study.

Coverage: The study will be conducted in 7 districts viz. Kamrup, Jorhat, Nagaon, Baksa, KarbiAnglong, Charaideo and Dhemaji district will be covered.

25 % of the schools and 30% of teacher trainees of the 7 districts will be covered under the study. Sampling of schools and teachers will be done by the study team.

Data collection: Data will have to be collected through classroom observation, interview with students and teachers. Minimum three visits per school for classroom observation will have to be carried out.

<u>Tools for data collection</u> like Observation Schedule (for classroom observation), Interview Schedule (for teachers and students), Tool for assessment/analysis of students' performance will be designed the by the Study Team and will be finalised after consultation with Teacher Training & Pedagogy and Research & Evaluation components of State Mission Office, SamagraShikshaAxom.

Data analysis: Data analysis will require analysis of classroom observation vis-à-vis the parameters/indicators as per the training objective and students' assessment analysis.
