CHAPTER-3

General Instructions

1. Definitions:

- a) "Railway" shall mean the President of the Republic of India or the General Manager of the Modern Coach Factory, Raebareli or the successors Railways authorised to invite e-tenders and enter into contracts for works on his behalf.
- b) 'Principal Chief Mechanical Engineer' shall mean the Officer-In-charge of the Mechanical Engineering Department of the Modern Coach Factory, Raebareli and shall mean and include their successors, of the successor Railway.
- c) "Engineer/executor" shall mean authorised personnel of MCF/RBL as authorised by CQM/MCF or Dy.CQM-I /MCF for the execution of said consultancy works
- d) Dy.CQM-I shall mean the executive in-charge of M&C Lab of MCF/RBL under CQM/MCF
- e) "MCF/RBL" shall mean Modern Coach Factory/Raebareli.
- f) **E-tenderer:** "E-tenderer" shall mean the person / the firm / co-operative or company whether incorporated or not who submitted these e-tender documents as an offer to carry out the work detailed in e-tender document of contract of contract with the Railways and shall include their personal representatives, successors and permitted assigns are termed e-tenderer(s) in these documents.
- g) The contractor(S): The e-tenderer(s) whose e-tender(s) has been accepted by the Railways shall thereafter be termed Contractor(s) and these e-tender documents of the accepted e-tender(s) shall become a part of the Contract/Agreement between the Contractor/s and the Railways.
- h) "Open E-tenders" shall mean the e-tenders invited in open and public manner and with adequate notice.
- 2. <u>Books of reference</u>: These e-tender documents are to be read in conjunction with "Indian Railway's General Conditions of Contract" as amended by updated correction slips till the date of opening of this e-tender which shall be referred as GCC hereafter.
- 3. <u>Scope of e-tender:</u> Online e-tenders are invited for and on behalf of the President of India for work described as "Work of Training, documentation, conducting PT, ILC, Payment of NABL Charges (Annual & Audit Expenses), Assistance during final Accreditation, Audit &NC closure, Lodging & boarding of NABL assessors for two years through private agency."
- **4.** Collection of data: Other information for the work, relevant to this e-tender, may be obtained from the office of CQM, Modern Coach Factory/Raebareli Lalganj, on any working day during working/office hours.
- 5. <u>Inspection of site</u>: E-tenderer must acquaint himself, at his own responsibility, risk and expense, with all information of the site of work and their neighbourhoods, actual working and other prevalent conditions, laws/regulations, availability and suitability of local labours, materials, accessibility of site of work sources and availability of water, electricity, camp site, market, banking facilities etc. and all such possible factors as have bearing on rates and progress of the work under this e-tender and all these factors should be taken into consideration before submitting this e-tender.
- 6. The contractor shall adhere to all applicable Labour Rules/Laws including Workman Compensation Act and other laws. The contractor must ensure that all workers working as a part of this contract are paid minimum wages as per Minimum Wage Act.

7. <u>E-tenderers's details:</u> Tenderer(s)/Bidders are advised to keep and maintain their information (like company profile, address, contact numbers, bank details etc.) up to date on Indian Railway tendering Portal i.e. <u>www.ireps.gov.in</u> as the tendering department may use this information for making payments to the bills, and for other statutory purposes.

8. Employment/partnership, etc. of retired railway employees:

- a) Should a e-tenderer be a retired engineer of the Gazetted rank or any other Gazetted Officer working before his retirement, whether in the executive or administrative capacity, or whether holding a pensionable post or not, in the Engineering or any other department of any of the Railway owned and administered by the President of India for the time being, or should a etenderer being partnership firm have as one of its partners a retired engineer or retired Gazetted Officer as aforesaid, or should a e-tenderer being an incorporated company have any such retired engineer or retired officer as one of its Directors, or should a e-tenderer have in his employment any retired Engineer or retired Gazetted Officer as aforesaid, the full information as to the date of retirement of such Engineer or Gazetted Officer from the said service and in case where such Engineer or Officer had not retired from Government service at least 2 years prior to the date of submission of the e-tender as to whether permission for taking such contract, or if the contractor be a partnership firm or an incorporated company, to become a partner or Director as the case may be, or to take the employment under the contractor, has been obtained by the e-tenderer or the Engineer or Officer, as the case may be from the President of India or any officer, duly authorised by him in this behalf, shall be clearly stated in writing at the time of submitting the e-tender. Etenders without the information above referred to or a statement to the effect that no such retired Engineer or retired Gazetted Officer is so associated with the e-tenderer, as the case may be, shall be rejected.
- b) Should a e-tenderer or contractor being an individual on the list of approved Contractors, have a relative(s) or in the case of partnership firm or company of contractors one or more of his shareholder(s) or a relative(s) of the shareholder(s) employed in Gazetted capacity in the Mechanical Engineering or any other department of the Indian Railways, the authority inviting e-tenders shall be informed of the fact (by filling information in **Annexure-I & II** of this e-tender document attached and named as **Annexure_I_Declaration_form_for_association_with_Railway_Officer** & **Annexure_II_Declaration_form_for_relation_with_MCF/RBL_Employee respectively** and submitting it with digital signature on IREPS portal i.e. www.ireps.gov.in) at the time of submission of e-tender, failing which the e-tender may be disqualified/rejected or if such fact subsequently comes to light, the contract may be rescinded in accordance with the provision in the General Conditions of Contract.

9. <u>Period of validity of e-tender:</u>

- 10. The e-tenderer(s) shall keep the offer open for a minimum period of 60 days from the date of online opening of the e-tender within which period the e-tenderer(s) cannot withdraw or modify his offer. The Railways Administration reserves right to request the extension of validity of offer from lowest, valid, eligible and technically acceptable e-tenderer (L-1) alone and award the contract accordingly. E-tenderer(s) with offers at higher price or technically unsuitable, not-eligible, invalid offers will not be entertained in such case. The Earnest Money referred to in this chapter is for the performance of the stipulation to keep the e-tender open for the aforesaid period. - b) The materials issued by the Railways to the contractor for use in the works shall be treated as Contractor's materials for this purpose, and the Contractor(s) shall make good these materials in the event of any loss or damage thereto.
- c) Works finished but not taken over by the Railways shall be treated as Contractor's materials for this purpose, and the Contractor shall be responsible for making good any loss or damage thereto.

12. Special conditions by e-tenderer (S):

- a) The e-tenderer(s) is, normally, not expected to make any special condition or stipulation of his own and is expected to submit his e-tender in accordance with the conditions or stipulations contained in these documents, if however, the e-tenderer(s) wishes to make any special condition or stipulation(s) or wishes to intimate the Railways of any matter of importance, he may do so in a covering letter. 20. Negotiation:

- b) L-1 should be defined as the lowest, valid, eligible and technically acceptable e-tenderer.
- c) Should such negotiation with the tenderer(s) be entered into, the tenderer(s) shall not be permitted to increase their quoted rates under any circumstances, even if it includes withdrawal or modification of such special conditions as are given by the tenderer(s) along with their original e-tender.
